#### THE POSITION

The Associate Vice President for Budget and Planning reports directly to the Vice President of Finance and Administration and has primary responsibility for the University's budget and financial planning responsibilities. The successful candidate will be a strong, collaborative leader with excellent communication and interpersonal skills. The University's budget leader must be a competent decision maker and have the ability to efficiently analyze information and issues to serve the needs of individual units while understanding the overall impact on the University's strategic goals. He/she must have the ability to effectively communicate strategies, ideas, concerns and propose solutions and strategies to meet financial objectives. This position requires strong financial planning and resource management experience as well as the ability to conduct and interpret financial analyses and develop sophisticated budget models and forecasts. The University's budget leader supervises a dedicated professional staff and ensures exceptional customer service.

#### **Specific Duties:**

- Administers and coordinates all aspects of the University's budget programs, processes and activities.
- Ability to lead a transformation of the University's current incremental budget process to an incentive based process that measures the return on investment in achieving quality improvements, increasing enrollments and meeting financial targets.
- As traditional revenue sources stabilize or decline, develops a model to incent new revenue growth and incorporate these revenue streams into the ongoing budget process.
- Serves as the University's budget representative for State Board of Education and State of Idaho budget issues. Supervises the University's external budget process, including preparation, review and submission of the operating and capital budget requests.
- Develops and delivers key presentations to University leadership and departments, external oversight agencies and other constituencies.
- Supervises the development, preparation, presentation and communication of the University's budget process for all fund sources.
- Develops budget strategies and recommendations and provides critical information to the Vice President of Finance and Administration. Serves as a primary liaison for campus leadership, faculty, staff, and students on strategies and plans related to budgets and financial plans.
- Oversees the development of timely budget and financial information to inform University departments of key trends and issues. Provides consultation and recommendations to solve or improve negative financial trends.
- Monitors key budget metrics and reports, and analyzes multi-year trends and impacts. Develops presentations with key data and indicators.
- Serves in a key leadership role for the annual tuition and fee request process, provides financial information and analyses that incorporates enrollments and key trends to support the process.
- Integrates University plans (e.g. strategic, development, enrollment, capital construction, and technology plans) into the budget process. Works closely with enrollment services, institutional research and provost's staff on enrollment and academic planning activities.
- Develops and proposes budget models and systems to improve budget processes, information and integration with key systems such as human resources, payroll and finance.
- Coordinates budget responsibilities with the University's finance and human resources operations to ensure that position management and compensation processes are properly managed.
- Recruits, supervises, develops and retains a high quality staff with excellent financial skills and a commitment to providing a high level of service and transparency to the University community.
- Demonstrates vision and creativity and is sensitive to the multi-faceted nature of a university environment.

#### Qualifications:

- Bachelor's degree in accounting, finance, or other business-related field required; Master's degree in business, finance, or public administration preferred.
- Minimum of eight years recent applicable experience in financial/budget management, with at least five years in a management and leadership role at a large organization. *Strong preference for higher education budgeting experience.*
- Expertise in the following areas:
  - Budget models and forecasting techniques
  - Budget and financial information systems
  - o Development and implementation of a strategic budget and planning process
  - o Leadership, communication and supervisory skills
