## THE OPPORTUNITY

### The Position:

In an effort to enhance campus risk management and compliance activities the Risk Manager/Assistant Compliance Officer will review, negotiate and recommend approval of all University loss prevention insurance purchases while establishing and implementing risk management policies and procedures. He/she will evaluate risks and non-compliance, conduct investigations, identify and provide advice to management on potential sources of loss as well as determine and implement strategies for loss prevention. Additionally, he/she will oversee administration of claims handling and investigation analysis reporting for claims by, and against the University as well as perform review of expenditures related to loss prevention insurance or self-insurance programs.

The Risk Manager/Assistant Compliance Officer will report to the University's General Counsel while supervising an Assistant Risk Manager/Workers Compensation Coordinator.

# Specific Responsibilities:

- Oversees processing of all property and liability insurance claims, obtains all pertinent information, and conducts investigations as needed in order to provide prompt service to University departments and non-University entities and/or individuals.
- In conjunction with legal counsel and related offices, conducts administrative investigations
  and ongoing compliance monitoring activities in coordination with other University
  compliance and operational risk assessment functions.

- Identifies and analyzes potential hazard/loss exposures through surveys, inspections, reports, investigations, audits, etc., to develop a means of improving the University's experience against loss.
- Evaluates risk, develops and implements strategy to safeguard the assets of the University; handles general, professional and other liability claims against the University, including notifying appropriate insurers, establishing reserves as appropriate, conferring with legal counsel, and assisting in the negotiation of settlements.
- Makes claims against property and other insurers on behalf of the University and assists in making recoveries from people who damage University property; assists with the allocation of insurance costs and/or self-insurance costs, whenever appropriate, to departments within the University.
- Oversees the reporting of University property and equipment value to insurers; provides
  periodic reports to administration regarding aspects of University risk management and loss
  prevention programs, including identified areas of risk, loss, inefficiency, and noncompliance; maintains awareness of legislative activities affecting risk management and
  recommends University actions related to such legislation.
- Reviews major leases, related contracts, proposed policies, programs, and affiliation agreements from a risk management point of view to ensure an effective loss prevention and loss control program is established and maintained.
- Other duties as assigned.

### Qualifications:

- Bachelor's degree in Business Administration, Accounting, Finance, or a related field.
   Master's degree preferred in business or a related field and/or a Juris Doctorate. An advanced degree may be considered in place of minimum years' experience requirement.
- Preference may be shown for demonstrated work experience in an academic setting and/or professional certification in the fields of risk management, accounting, auditing, and/or property/casualty underwriting.
- Seven years' related experience that includes exposure to conducting investigations, audit practices, human resource management and applicable law; working knowledge of risk management insurance principles desirable.
- Effective oral and written communication skills.
- Commitment to providing excellent customer service to the University community and administration.
