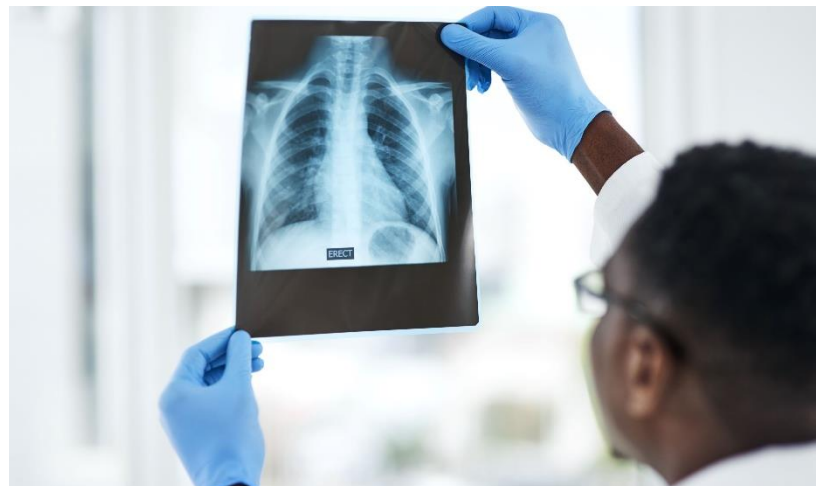

THE OPPORTUNITY

Executive Dean, College of Chiropractic Education

This is a once-in-a-career opportunity for an accomplished and driven leader to influence the future of chiropractic education. The inaugural Executive Dean for the College of Chiropractic Education is charged with creating the future of chiropractic education at SCU, building upon the Los Angeles College of Chiropractic's 100+ year history to establish Southern California University of Health Sciences as the leading chiropractic institution. The ideal candidate is an effective academic leader, a capable business unit manager, and a forward thinker.

The creation of the College of Chiropractic Education is prompted by the University's growth and strategic priorities. The Executive Dean will a) oversee the geographic expansion of chiropractic education to three additional locations outside California including hiring and mentoring program directors for each location b) oversee a major program redesign to ensure the Doctor of Chiropractic is a leading high-quality, relevant, innovative, and accessible program c) work with the Los Angeles College of Chiropractic faculty and administration to identify and address opportunities to improve the faculty experience d) engage with the SCU Health Services and the Center for Interprofessional Education to identify opportunities to break down silos and improve the student experience e) enthusiastically and capably represent the profession and program nationally to accreditors, professional associations, state licensing bodies, and other external agencies f) maintain and build enrollment to continue LACC's long history of preparing integrative, evidence-based chiropractors.

In overseeing the program redesign, the Executive Dean will build on the successful model of other healthcare professions like Physical Therapy to explore accelerated, hybrid, and other innovative models of delivery.

The Executive Dean will join a team of highly committed colleagues dedicated to growing the University while maintaining its successful student outcomes and unique, collaborative, supportive campus community. The University was commended by its accreditation agency WSCUC and by the Council on Chiropractic Education for its strong commitment to its mission and values including interprofessional education and integrative, whole-person health; the dedication of its faculty and staff to continuous improvement; its significant investments in personnel and technology; its collaboration across departments to address achievement gaps and provide academic support throughout the student experience; and a responsive and dedicated staff who care deeply about the success of faculty, students, and the institution as a whole. The Executive Dean will be expected to build upon the solid foundation of academic excellence built over the University's 100+ year history and be a champion of whole-person health.

The Executive Dean will report to the Vice Provost under a multi-college structure that includes the new College of Chiropractic Education (COCE) as well as the College of Health Professions (COHP), College of Medical Sciences (COMS), and Center for Interprofessional Education (CIPE).

Remote Opportunity: This position will require building strong relationships across the campus and nationally. Candidates for this position will have the option to work on campus, hybrid, or in a fully remote capacity. Travel to the main campus in Whittier and to future learning sites is expected to build relationships and attend key events and meetings. Travel costs will be budgeted for and covered by the University.

Duties and Responsibilities – Your Mission:

- Oversee the redesign of the DC curriculum.
- Oversee current and future geographical expansion of the College; identify new program-related opportunities.
- Oversee program effectiveness processes, ensuring academic excellence and accreditation compliance.
- Monitor and mentor program leadership including in the areas of budgeting and resource management, faculty management and development, assessment and program review, and accreditation management.
- Monitor, identify, and implement opportunities for improvement in key operational indicators (e.g., average class size, faculty workload).
- Monitor, identify, and implement opportunities for improvement in key academic indicators (e.g., accreditation, student outcomes, student support).
- Ensure effective management of and compliance with programmatic accrediting, licensing, and other regulatory bodies for all sites.
- Participate in and ensure the successful completion of substantive change proposals to WSCUC.
- Oversee CCE accreditation.
- Oversee compliance with state licensing agencies/boards for chiropractic education.
- Identify and develop partnerships and articulation agreements to maintain and grow College enrollment.
- Identify and develop opportunities to advance the reputation and visibility of the LACC (e.g., partnerships, presentations, service).
- Identify and cultivate relationships with relevant healthcare partners to expand clinical site access nationally.
- Assist programs with developing and leveraging Program Advisory Boards.
- Ensure appropriate representation from the College on University councils and committees, including providing opportunities for faculty development.
- Oversee College budgeting and planning.
- Manage supplies and equipment including creation and maintenance of long-range capital plans and supply management processes.
- In collaboration with Operations, manage classroom facilities, supplies, and equipment.
- In collaboration with the Center for Faculty Development and Excellence, ensure faculty development and training meets the needs of the College and its faculty.
- In collaboration with the Center for Interprofessional Education, identify and promote opportunities for both faculty and students in Interprofessional Education.
- In collaboration with Marketing and Admissions, establish and meet College enrollment goals.
- In collaboration with Student Affairs, ensure student and academic support meets the needs of the College's students.
- Lead projects or initiatives at the request of the Vice Provost, AVPAA.
- Participate in University and College activities, task forces, and committees.
- Other duties as assigned.

Qualifications:

- A Doctor of Chiropractic Degree from an accredited college or university and an appropriate professional credential/license.
- A minimum of 5 years of experience in higher education; overseeing academic programs is preferred.
- A record of successful administrative leadership at the dean, chair, or program director level, preferably in an evidence-based focused program, college, and/or university or the equivalent in a healthcare field.
- Experience managing programmatic accreditation preferred.
- Deep understanding of clinical site procurement and management both locally and nationally.
- Deep understanding of program development, curriculum mapping, assessment, and program review.
- Experience working with multiple external agencies, such as accreditors, governmental agencies, and clinical site providers.
- Budget management experience.
- University level teaching experience.
- Experience with innovative program design such as online, blended, accelerated, and competency-based education.
- Experience in an interprofessional education setting.
- Track record of successful grant procurement is a plus.

Desired Skills, and Abilities:

- Capable and enthusiastic mentor interested in hiring, developing, and managing program directors and other college administrators.
- Extremely comfortable managing change and growth.
- Knowledge of key principles of enrollment management and academic program sustainability.
- Experience working with diverse stakeholders to establish and achieve goals and support institutional and college strategic direction.
- A data informed planner with experience.
- Alignment with the values of integrative, whole person health and inclusivity, health equity, evidence-based practice.
- Exceptional communicator, listener and diplomatic leader who can work in a collegial manner with faculty, staff, and other campus and community constituents.

Whittier has a unique combination of community identity, spirit, and cooperation that have helped make it one of the most attractive and desirable residential and business locations in Southern California. Located in Los Angeles County, about 12 miles southeast of the City of Los Angeles, it boasts beautiful year-round weather with temperatures rarely reaching above 90 degrees or below 50 degrees.

Living in Whittier offers residents a small-town feel but with the benefits of a large metropolitan area with access to a vast array of cultural and recreational opportunities. In addition to all the attractions offered by the private sector, the County has several world-class facilities including the Music Center, Hollywood Bowl, Museum of Art, the Natural History Museum, the Ford Theatre, and Marina del Rey. The County manages 87 regional and local parks, 344 miles of horse and hiking trails, 19 golf courses, 31 public swimming pools, and 25 miles of beaches.
